About the Whitehorse Micro Funds

Whitehorse City Council recognises that smaller funds within the community provide important opportunities for local vulnerable people and can help maintain their social connections and overall wellbeing.

This funding can help manage the costs associated with providing activities that will enhance participation in the community, help reduce social isolation or loneliness, or purchase equipment.

Who is this fund for?

These funds provide support for small projects/ initiatives or equipment purchases for local community groups that **demonstrate financial need**. There are available until the budget allocation is exhausted.

When is this fund available?

Micro Funds are available on a **tri-annual basis**, with three funding rounds offered each year in **March, July, and November**.

Each round operates on a **first in, best dressed** basis, meaning applications are assessed and funded in the order they are received until all available funds are allocated.

Applicants can apply for funding in each round available in the year (up to \$3,000 max funding), however preference will be granted to applicants who have not received funding.
